SUBJECT: Approval of the Agreement between Inland Empire Health Plan and Riverside County Community Health Agency (CHA) for Coordination of Public Health Services.

**RECOMMENDED MOTION:** That the Board of Supervisors: 1) Approve the Agreement between the Inland Empire Health Plan (IEHP) and the Riverside County Community Health Agency to provide coordination of public health services for an annual amount of \$50,000 for the performance period ending December 30, 2003. Thereafter, the term of the Agreement shall automatically be extended for four (4) additional successive one (1) year terms, unless terminated; 2) Direct the Auditor-Controller to adjust the budget as detailed in Schedule A; 3) Authorize the Chairperson to execute said Agreement on behalf on the County; and 4) Direct the Clerk of the Board to retain one (1) signed original and returned three (3) signed original agreements to the Community Health Agency Contracts Administrator.

**BACKGROUND:** IEHP, as a Local Initiative Medi-Cal Managed Care Plan, is required to coordinate public health services with the public health departments of Riverside and San Bernardino Counties. This Agreement delineates areas of understanding and agreement between the Riverside County Community Health Agency, Department of Public Health and IEHP.

**SUBJECT:** Approval of the Agreement between Inland Empire Health Plan and Riverside County Community Health Agency (CHA) for Coordination of Public Health Services.

**BACKGROUND:** Public Health services provided by this Agreement include education, prevention and treatment of Sexually Transmitted Diseases, HIV Services, Family Planning, Medical Nutrition Therapy, Tuberculosis Control, Immunizations, Communicable Disease Control, Perinatal, Child and Adolescent Health Services, California Children Services, Special Supplemental Nutrition Program for Women, Infants and Children (WIC), and home visits. In addition to providing a framework for coordinated services, the Agreement provides for IEHP to reimburse Riverside County for specified services such as prevention and treatment of STDs, Family Planning, and Medical Nutrition Therapy Services on a fee-for-service basis utilizing Medi-Cal rates. Other services are specified as "bundled" services and IEHP will reimburse the Riverside County the amount of \$50,000 annually.

This Agreement has been approved as to form by County Counsel.
