



**JUSTIFICATION:**

The City of Desert Hot Springs has requested the reprogramming of funds to the new project "Desert Hot Springs Skateboard Park". The Economic Development Agency concurs with this request. The City of Desert Hot Springs has requested the reprogramming of funds to the "Desert Hot Springs Skateboard Park Project". The project consists of the construction of a new skateboard park to benefit low and moderate-income youth of Desert Hot Springs. Once the project is completed the City of Desert Hot Springs expects to serve approximately 200 youth per year.
