SUBJECT: Change the name of Killen Trail to South Main Divide Road, in the Lake Elsinore area, First Supervisorial District.

RECOMMENDED MOTION: That the Board Adopt Resolution No. 2003-17, Change the Name of Killen Trail to South Main Divide Road in the Lake Elsinore area.

BACKGROUND: The property owners abutting Killen Trail, along with those that use Killen Trail for access, have requested this name change. Killen Trail was known as South Main Divide Road for many years prior to a name change on August 14, 1990. Mr. Killen, the roads namesake moved from the area several years ago and the remaining property owners would like the name changed back to South Main Divide Road. The road continues to be known as South Main Divide Road as well as Killen Trail and officially changing the name back to South Main Divide Road will eliminate the confusion. Recent events surrounding the Samantha Runnion abduction and murder and its proximity to Killen Trail, have also prompted this request.

10 **Killen Trail** between State Highway 74 (Ortega Highway) and the southerly line of Section 36,
11 T.6 S., R. 5 W., S.B.B. & M., as shown on Record of Survey, recorded in Book 69, Pages 22
12 through 24 inclusive of Records of Survey, records of the Recorder, Riverside County,
13 California, in Sections 15, 16, 22, 23, 25, 26 and 36, T. 6 S., R. 5 W., S.B.B. & M., First
14 Supervisorial District, and all persons having had an opportunity to be heard; now, therefore,
