

SUBJECT: Grant Agreement with the Wildlife Conservation Board

RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve attached Resolution Number 2003-143, which authorizes the acceptance of a grant from the Wildlife Conservation Board; and
2. Approve the attached grant agreement between the County of Riverside and the Wildlife Conservation Board, and authorize the Chairman to sign the agreement.

BACKGROUND: On January 7, 2003, item 3.9, the Board of Supervisors approved Resolution Number 2003-7 giving authorization to acquire an approximately 192.86 acre property. The subject property is located north of Highway 74 and east of El Toro Canyon Road in the Alberhill area. The property will be purchased with \$1,000,000.00 in federal funds and \$350,000.00 in matching state funds. Today's action before the Board of Supervisors will authorize the County to accept these grant funds to acquire the subject property. County Counsel has approved the grant agreement as to form. Staff recommends approval of the two motions in this form 11.

3 **AUTHORIZATION TO ACCEPT A GRANT FROM THE WILDLIFE**
4 **CONSERVATION BOARD**
5 **(First Supervisorial District)**

6 **WHEREAS**, On January 7, 2003, the Board of Supervisors of the County of
7 Riverside authorized the acquisition of a 192.86 acre property located north of Highway
8 74 and east of El Toro Canyon Road in the Alberhill area; and

9 **WHEREAS**, On February 11, 2003, the Wildlife Conservation Board agreed to
10 grant \$350,000.00 to the County of Riverside as a non-federal match for a
11 \$1,000,000.00 federal grant to acquire the subject property; and

12 **WHEREAS**, the County is willing to accept the grant from the Wildlife
13 Conservation Board; and

14 **WHEREAS**, the acceptance of this grant will assist the County in providing open
15 space for preservation of wildlife and plant life;

16 **NOW THEREFORE, BE IT RESOLVED, DETERMINED, AND ORDERED** by the
17 Board of Supervisors of the County of Riverside, State of California, in regular session
18 assembled on April 8, 2003, as follows:

19 1. That the Board of Supervisors hereby finds and declares that the above
20 recitals are true and correct.

21 2. That the County of Riverside is authorized to accept a grant from the Wildlife
22 Conservation Board for the sum of \$350,000.00 as a non-federal match for another
23 \$1,000,000.00 grant from the federal government.

24 3. That the Chairman of the Board of Supervisors is hereby authorized to execute
25 any and all documents necessary to accept the grant from the Wildlife Conservation
26 Board.
