SUBJECT: Establishing an Emergency Services Benefit Zone within County Service Area 152, Public Hearing.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Conduct the public hearing for the project; and
- 2) Upon close of the Public Hearing, adopt Resolution No.2003-117, Establishing An Emergency Services Benefit Zone within County Service Area 152, Emergency Services CSA 152"D".

BACKGROUND: Pursuant to Government Code 25210.8, the Board of Supervisors has the authority to establish benefit zones within any County Service Area. The residents of the unincorporated areas of Wildomar, La Cresta, Plateau and Farm have requested additional emergency services be provided to these areas. Therefore, it is recommended that CSA 152 "D" Benefit Zone be created to enable emergency services to be provided in the Wildomar, La Cresta, Plateau and Farm areas. The emergency services will be provided to the specified geographical location as described in Exhibit "A".

3 ESTABLISHING AN
4 EMERGENCY SERVICES BENEFIT ZONE WITHIN
5 COUNTY SERVICE AREA NO. 152

6 WHEREAS, Government Code §25210.8 enables the Board of Supervisors to establish zones
7 within any County Service Area, with tax rates, service charges, or benefit assessments varying with the
8 extent of benefit to each zone; and

9 WHEREAS, it is appropriate that a Benefit Zone be created to enable emergency services to be
10 provided in the Wildomar, La Cresta, Plateau and Farm areas; and

11 WHEREAS, a public hearing was conducted by the Board on April 15, 2003 after which this
12 Board determined that public convenience and necessity require that Benefit Zone "D" should be
13 established for the Wildomar, La Cresta Plateau and Farm areas, as more particularly described in Exhibit
14 "A," attached hereto.

16 NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of
17 Riverside, State of California, in regular session assembled on April 15, 2003, that Benefit Zone "D" is
18 hereby established within CSA 152, consisting of Wildomar, La Cresta, Plateau and Farm, as more
19 particularly described in Exhibit "A," attached hereto.


