WHEREAS, Tyree Ellison celebrates 50 years of dedicated criminal justice service to the people of the County of Riverside on May 28, 2003; and

WHEREAS, he began his career with the Probation Department on May 28, 1953, as a Group Counselor at Riverside County Juvenile Hall; and

WHEREAS, he was promoted to Senior Group Supervisor in January 1960 and served in that capacity for nine years; and

WHEREAS, he was promoted to Institutional Probation Officer in July 1969 and reclassified to Supervising Probation Officer in June 1989; and

WHEREAS, Supervising Probation Officer Tyree Ellison was transferred to Van Horn Youth Center in 1992 and has served there for the past 13 years; and,

WHEREAS, Tyree Ellison distinguished himself in the performance of outstanding service to the County and citizens of Riverside County as Supervising Probation Officer from July 30, 1969 to May 28, 2003; and

WHEREAS, during this period the professional skill, leadership and ceaseless efforts of Supervising Probation Officer Ellison resulted in major contributions to the effectiveness of the Probation Department institutions; and

WHEREAS, the lives of countless minors who were under his supervision have been changed forever; and

WHEREAS, in addition to his status as Supervising Probation Officer, Tyree Ellison has served as a speaker in the Probation Department's Speakers Bureau and a leader in the Young Men as Fathers Program; and

WHEREAS, Tyree Ellison has earned the respect of the County's criminal justice agencies, the courts, social service, and mental health agencies and, in particular, fellow employees with the Probation Department; and
