SUBJECT: Public Auction Sale of Tax-Defaulted Real Property, Sale No. TC-168, scheduled for July 14, 2003 through July 21, 2003 to be auctioned via the internet.

RECOMMENDED MOTION: That the Board of Supervisors:

1) Approve the intended public auction tax sale, TC-168, 2) Approve and adopt provisions of the Revenue and Taxation Code Section 3698.5(a), 3698.5(c) and section 4703(a), 3) Adopt Resolution 2003-280 approving the sale of tax-defaulted property, prepared and approved by County Counsel, and 4) Instruct the Clerk of the Board to immediately forward a certified copy of the Board's Resolution to the Tax Collector following Board approval.

The above action will authorize the minimum bid on tax-defaulted real property to be offered at the public auction tax sale.

BACKGROUND: Properties for which taxes are not paid are sold to collect back taxes. After property has been tax-defaulted for a period of five or more years from the original tax-default year, it becomes subject to the Tax Collector's "Notice of Power to Sell Tax-Defaulted Property" which is then recorded. If the property is not subsequently redeemed by the payment of all amounts due, it is to be offered for sale by the Tax Collector. (Continued)

BACKGROUND: (Continued)

SUMMARY OF THE JULY, 2003 INTERNET TAX SALE:

The Tax Collector will offer for sale a total of one hundred ninety-eight (198) "fee parcels", or less, for a minimum bid of \$540.00 each, which represents the cost of sale. We have offered all of these parcels at previous sales at least twice with no bids being received.

We will be using a different Internet bidding service, Bid4Assets, because they provide marketing services, which were not offered by Yahoo! Based upon discussions with other counties using Bid4Assets, we believe that this will bring higher bids on the parcels offered.

As indicated in Exhibit "A", the aggregate minimum bid for all parcels is \$ 106,920.00.

Sales at, or above, the amount of taxes owed have no direct impact on the County's budget. Sales of less than the amount of taxes owed have an indirect impact on the County's budget. As long as the tax loss (taxes owed minus net sales price) is within the budgeted amount in the teeter plan, no subsequent adjustments to the General Fund Budget are required. If all parcels being reoffered for sale sell for the minimum bid, the maximum tax loss would be \$671,260.59. Taking into account the Teeter formula, maximum loss to the Tax Loss Reserve Fund would be \$557,146.29. At that level there would be no direct impact on the County General Fund because reserves exceeding that amount have been designated. More likely than not, there will be no overall impact upon the Tax Loss Reserve Fund itself, either.

Based upon past experience, this sale will not realize the maximum loss for three reasons: (i) properties are inevitably pulled from the sale due to bankruptcy or taxpayer redemptions; (ii) some parcels will likely sell for more than the minimum bid and (iii) other parcels are likely to receive no bids.

11 sale; and any postponement of the sale that may be necessary; the Tax Sale List TC 168, Sale File 4302 is
12 attached herewith as Exhibit "A" and sets forth the property declared tax-defaulted with the year of the tax-
13 default and the assessment number; and

14 WHEREAS, the Tax Collector in his discretion has determined that the property specified in
15 Exhibit "A," attached hereto and incorporated by reference, should be offered for sale on July 14, 2003
16 through July 21, 2003 at a minimum bid in accordance with California Revenue and Taxation Code
17 Sections 3698.5(a), and

18 WHEREAS, one hundred and ninety-eight fee parcels, or less, previously offered will be re-
19 offered at a reduced bid at the July 2003 tax sale; and

20 WHEREAS, it is in the best interests of the State of California, the County of Riverside, and
21 cities, school districts, and special districts for whom the Tax Collector collects taxes, to sell said
22 properties; now, therefore,

23 BE IT RESOLVED, DETERMINED, AND ORDERED by the Board of Supervisors of the
24 County of Riverside, State of California, in regular session assembled on June 17, 2003, that the proposed
25 sale of tax-defaulted property subject to the power of sale and any continuation of the sale is hereby
26 approved and the Tax Collector of the County of Riverside is directed to offer the property described in
27 Exhibit "A" attached hereto and incorporated by reference, at public auction to the highest
