SUBJECT: FAPP-3046 FEDERAL ALTERNATIVE PAYMENT PROGRAM LOCAL AGREEMENT

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Approve and authorize the Chairman of the Board to sign the attached FAPP-3046 Federal Alternative Payment Program Local Agreement for child care services between the Department of Public Social Services (DPSS) and the California Department of Education (CDE) totaling \$2,200,329 covering the term July 1, 2003 through June 30, 2004; and
- 2) Adopt Board Resolution #2003-316

BACKGROUND: Each year CDE allocates state funding to DPSS so that eligible families and/or children, as defined by the CDE who meet the criteria of the California Education Code, can receive subsidized child development services. This year's allocation is provided in Local Agreement FAPP-3046. Therefore, the Director of DPSS respectfully requests approval of the FAPP-3046 Local Agreement for child care services with CDE for FY 03/04.
