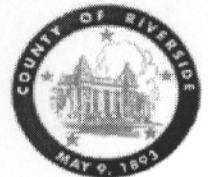

SUBJECT: NOTICE OF INTENT TO CONDEMN REAL PROPERTY FOR FREEWAY IMPROVEMENT PURPOSES-STATE OF CALIFORNIA, DEPARTMENT OF TRANSPORTATION - INTERSTATE 215/91/60 SEQUENCING PROJECT

RECOMMENDED MOTION: That the Board of Supervisors consider approving Resolution 2003-339, Notice of Intent to Condemn Real Property for Caltrans Parcel 18029 for freeway improvement purposes, on behalf of the State of California, Department of Transportation (Caltrans), for the Interstate 215/91/60 Sequencing Project, and to set a public hearing for Resolution 2003-345, Authorizing Condemnation of Real Property for Freeway Improvement Purposes, on August 26, 2003.

BACKGROUND: Pursuant to Minute Order 3.33 approved by the Board of Supervisors on November 26, 2002, a resolution was passed agreeing to hear Resolutions authorizing Condemnation on behalf of the State of California, Department of Transportation. As a prelude thereto, it is necessary for the Board to consider adopting Resolutions of Notice of Intent to Condemn Real Property for parcels affected by the project.

4 NOTICE OF INTENTION TO CONDEMN REAL PROPERTY
5 FOR FREEWAY IMPROVEMENT PURPOSES

6 BE IT RESOLVED, FOUND, DETERMINED, AND ORDERED by the Board of
7 Supervisors of Riverside County, State of California, in regular session assembled on
8 July 29, 2003, and NOTICE IS HEREBY GIVEN as follows:

9 1. That this Board will consider passing a resolution of necessity
10 authorizing the condemnation of certain parcels of real property for freeway
11 improvement purposes described as portions of Assessor's Parcel Number 291-020-
12 015, 291-020-016, 291-020-017, 219-040-031, 219-040-032, 219-040-033 and 219-
13 040-049, also known as Caltrans Parcel #18029, shown as legal descriptions and plat
14 maps on file in the Office of the Clerk of the Board, and located in Riverside, and to hold
15 a public hearing on August 26, 2003, at 10:00 a.m. in the meeting room of the Board of
16 Supervisors located on the 1st Floor, County Administrative Center Annex, 4080 Lemon
17 Street, Riverside, California, at which time the person or entity whose real property is
18 sought to be condemned and whose name and address appears on the last equalized
19 County Assessment Roll and who has filed a timely written request to appear and be
20 heard, will be given an opportunity to be heard on the following matters:

23 a. Whether the public interest and necessity require the
24 construction of the public improvement.

25 b. Whether the public improvement is planned and located in
26 the manner that will be most compatible with the greatest public good and the least
27 private injury.


1 c. Whether the real property sought to be acquired is
2 necessary for the construction of the public improvement.

3 2. That the failure of any person, whose real property is sought to be
4 condemned, to file a written request to appear and be heard with the Clerk of the Board
5 within 15 days after a copy of the resolution is mailed to, or personally served upon
6 such person, will result in his or her waiver of the right to appear and be heard.

8 BE IT FURTHER RESOLVED that the State of California, Department of
9 Transportation, has caused a letter of intent, see attached, and a copy of the right of
10 way map to be mailed to or personally served upon each person or entity whose real
11 property is sought to be condemned and whose name and address appears on the last
12 equalized County Assessment Roll.
