**BACKGROUND:**

SCG provides funding for the Riverside County weatherization programs to install weatherization measures and replace water heaters in homes of eligible low-income residents.

This Change Order #2003-01 to Agreement #SCGDAP2003-12 with SCG would require that DPSS-DCA conduct additional gas appliance testing (GAT) as outlined in the California Statewide Low Income Energy Efficiency (LIEE) Policy and Procedures Manual. In exchange for conducting this additional test, SCG will pay DPSS-DCA at the increased rate of \$24.00 per home for this testing, and an additional \$1.00 per home because the funding is leveraged, for a total of \$25.00 per home. All other terms and conditions remain the same.

The Director of DPSS-DCA requests that the Board of Supervisors approve Change Order #2003-01 to Agreement #SCGDAP2003-12 with Southern California Gas Company, not to exceed \$60,000. Agreement #SCGDAP2003-12 covers the term December 16, 2002 through December 31, 2003.

**FINANCIAL IMPACT:** No County General Funds will be required.
