**BACKGROUND:**

On August 10, 1999 (Agenda #3.72), the Board of Supervisors approved a Standard State Personal Services contract No. 99138 for Joann Winternheimer for the contract period of July 1, 1999 through June 30, 2003. Ms. Winternheimer served in the capacity of County Consultant for the purpose of providing personal services to the Child Welfare System / Case Management Systems (CWS/CMS) Project.

On June 30, 2003, Ms. Winternheimer retired from Riverside County Department of Public Social Services. DPSS and the State Health and Human Services Data Center has agreed that due to her extensive experience and value to Riverside County and Child Protective Services, they would like Ms. Winternheimer to continue in her consultant capacity after she retires. She would be employed as a part-time retired annuitant at her current pay rate of \$29.90 limited to 960 work hours per year for an amount not to exceed \$28,704.

Under the terms of this Contract the State agrees to reimburse the County for actual costs incurred by the County for her salary. Ms. Winternheimer is not eligible for county benefits as a Retired Annuitant.

**FINANCIAL IMPACT:**

This is 100% State Reimbursement. No County general funds are required.
