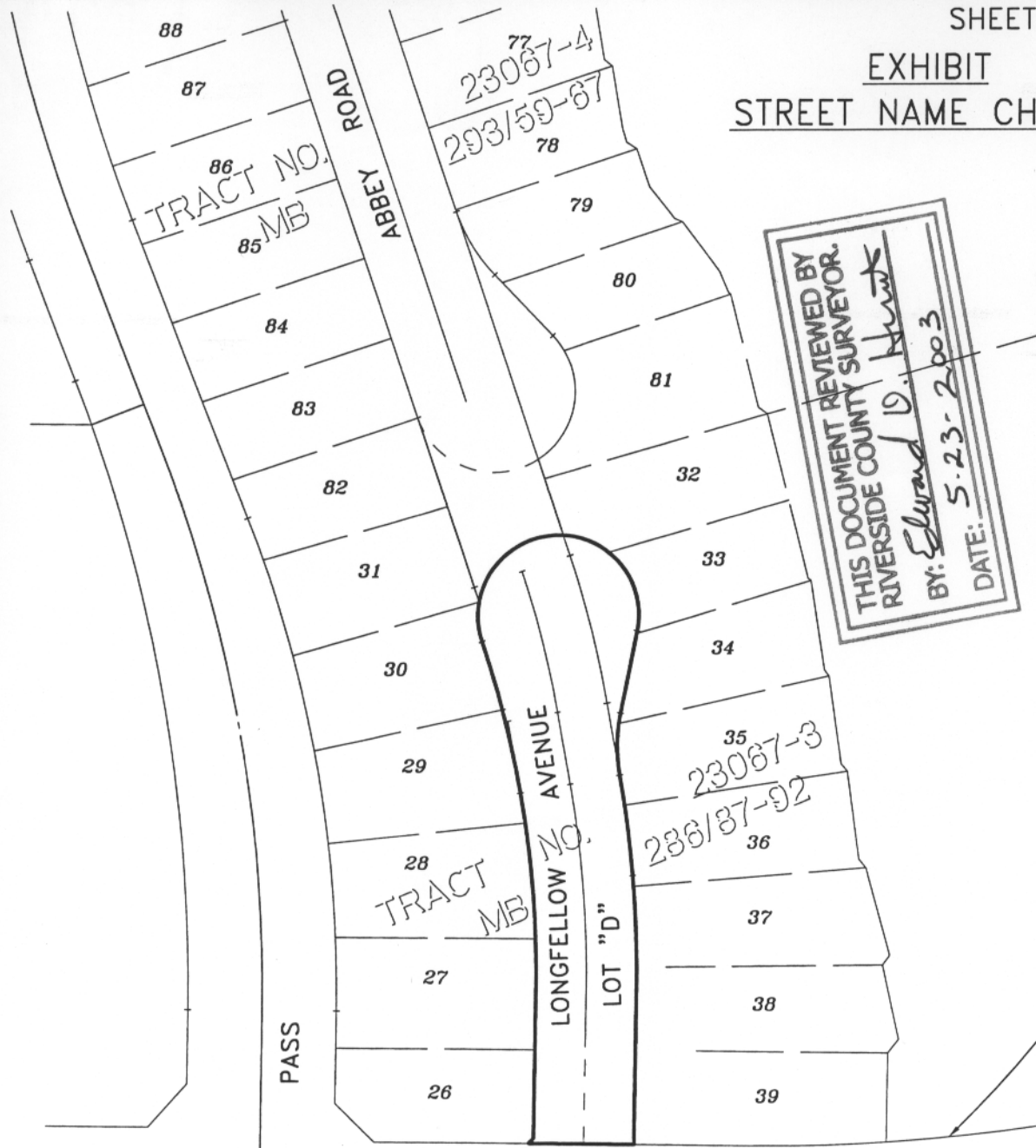

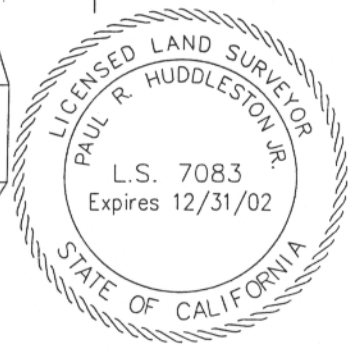

REC. AS INST. O.R.

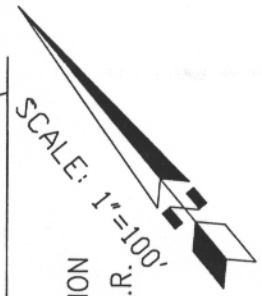
