Staff is directed to cause the appropriate resolution, based on the election tally, to be prepared and returned to the Board on August 19, 2003 for its consideration.

BACKGROUND:

Pursuant to the Landscaping and Lighting Act of 1972 and Resolution 2003-232 adopted June 3, 2003, the Board of Supervisors noticed a public hearing for July 29, 2003, to receive testimony regarding the annexation of Location 32 into Zone 3 of Landscaping and Lighting Maintenance District No. 89-1-Consolidated (L&LM Dist. No. 89-1-C). Annexation of Location 32 into Zone 3 will fund the maintenance and servicing of landscaping improvements within the public right-of-ways located north of Honeyrun Rd. easterly and westerly of La Ladera Rd. in the Menifee area and includes 154 single-family residential lots.

On June 4, 2003, a notice of the public hearing and mail-in ballot, an impartial analysis, a copy of Resolution No. 2003-232 and an information sheet was mailed to all property owners within Location 32 proposed for annexation into Zone 3 of L&LM Dist. No. 89-1-C. Pursuant to the notice, all ballots must be returned prior to the conclusion of the public hearing.

Notice of the public hearing was also given by publication of a certified copy of Resolution No. 2003-232 in The Press Enterprise at least ten (10) days prior to the public hearing date and by posting a certified copy of the Resolution no. 2003-232 on the official bulletin board customarily used by the Board of Supervisors for the posting of notices and in two other public locations within the County.

Section 53753 of the Government Code has been amended. It requires that the Board after conducting the public hearing designate and impartial person, having no vested interest in the outcome of the proposed annexation, to tally the ballots received by the close of the public hearing at a specified time, date and place.
