**BACKGROUND:**

Pursuant to the Landscaping and Lighting Act of 1972 and Resolution 2003-247 adopted June 10, 2003, the Board of Supervisors noticed a public hearing for July 29, 2003, to receive testimony regarding the annexation of Zone 15 into Landscaping and Lighting Maintenance District No. 89-1-Consolidated (L&LM Dist. No. 89-1-C). Annexation of Zone 15 will fund the maintenance and servicing of landscaping and catch basin filtration system improvements within public right-of-ways located northeasterly of Lyon Ave. between Victoria Ave. and Mont Blanc Dr.; southwesterly of Victoria Ave. easterly of Lyon Ave.; northwesterly and southeasterly sides of Dufferin Ave. between Lyon Ave. and Traditions Ct.; northwesterly of Dufferin Ave. between Traditions Ct. and La Sierra Ave.; southwesterly of La Sierra Ave. northerly of Dufferin Ave. in the La Sierra area and includes 61 single-family residential lots.

On June 11, 2003, a notice of the public hearing and mail-in ballot, an impartial analysis, a copy of Resolution No. 2003-247 and an information sheet was mailed to all property owners within Zone 15 proposed for annexation into L&LM Dist. No. 89-1-C. Pursuant to the notice, all ballots must be returned prior to the conclusion of the public hearing.

Notice of the public hearing was also given by publication of a certified copy of Resolution No. 2003-247 in The Press Enterprise at least ten (10) days prior to the public hearing date and by posting a certified copy of the Resolution no. 2003-247 on the official bulletin board customarily used by the Board of Supervisors for the posting of notices and in two other public locations within the County.

Section 53753 of the Government Code has been amended. It requires that the Board after conducting the public hearing designate and impartial person, having no vested interest in the outcome of the proposed annexation, to tally the ballots received by the close of the public hearing at a specified time, date and place.
