**BACKGROUND:**

On July 29, 2003, a public hearing was held to receive all testimony regarding the annexation of Zone 29 into Landscaping and Lighting Maintenance District No. 89-1-Consolidated ("L&LM Dist. No. 89-1-C"). After closing the public hearing, the Board directed the Director of Transportation, or his/her designee, to tally the ballots that had been received prior to the close of the hearing. The ballots were to be tabulated on July 30, 2003 at 10:00 a.m. in Conference Room B on the 8<sup>th</sup> Floor of the County Administrative Center. The tabulation shows that votes representing 130 parcels out of a possible 130 parcels were cast, and that 130 votes (or 100%) were cast in favor of the annexation of Zone 29 of L&LM Dist. No. 89-1-C and the levy and enrollment of the special assessment.

Adoption of Resolution No. 2003-362 confirms the assessment levy as indicated in the Engineer's Report for fiscal year 2003-04 for Zone 29 of L&LM Dist. No. 89-1-C and orders the placement of the annual assessment on the County's Assessment Roll for fiscal year 2003-04.
