SUBJECT: Resolution 413-539 to Establish a No-Parking Zone, Hemet area

RECOMMENDED MOTION:

That the Board adopt Resolution 413-539 to establish a No-Parking Zone on New Chicago Avenue in the Hemet area, as described in attached Resolution 413-539.

BACKGROUND:

The Transportation Department was contacted by a resident in the Hemet area requesting a centerline stripe on New Chicago Avenue between Acacia Avenue and Putters Lane. Due to the alignment of New Chicago Avenue across Acacia Avenue, the installation of a no-parking zone on the east side of New Chicago Avenue between Acacia Avenue and Fore Drive will be necessary in order to install the centerline.

Transportation Department staff conducted a field review of the site and determined that the installation of a centerline stripe on New Chicago Avenue is appropriate. Therefore, we recommend the installation of the proposed No-Parking Zone. We have contacted the affected property owners by mail and received no objections to the proposed No-Parking Zone.

Based on this review, the Transportation Department recommends approval of this No-Parking Zone.

The Transportation Department staff has contacted the San Geronio Pass Area office of the California Highway Patrol regarding the proposed zone.

County Counsel has approved this resolution.

8 Hemet area:

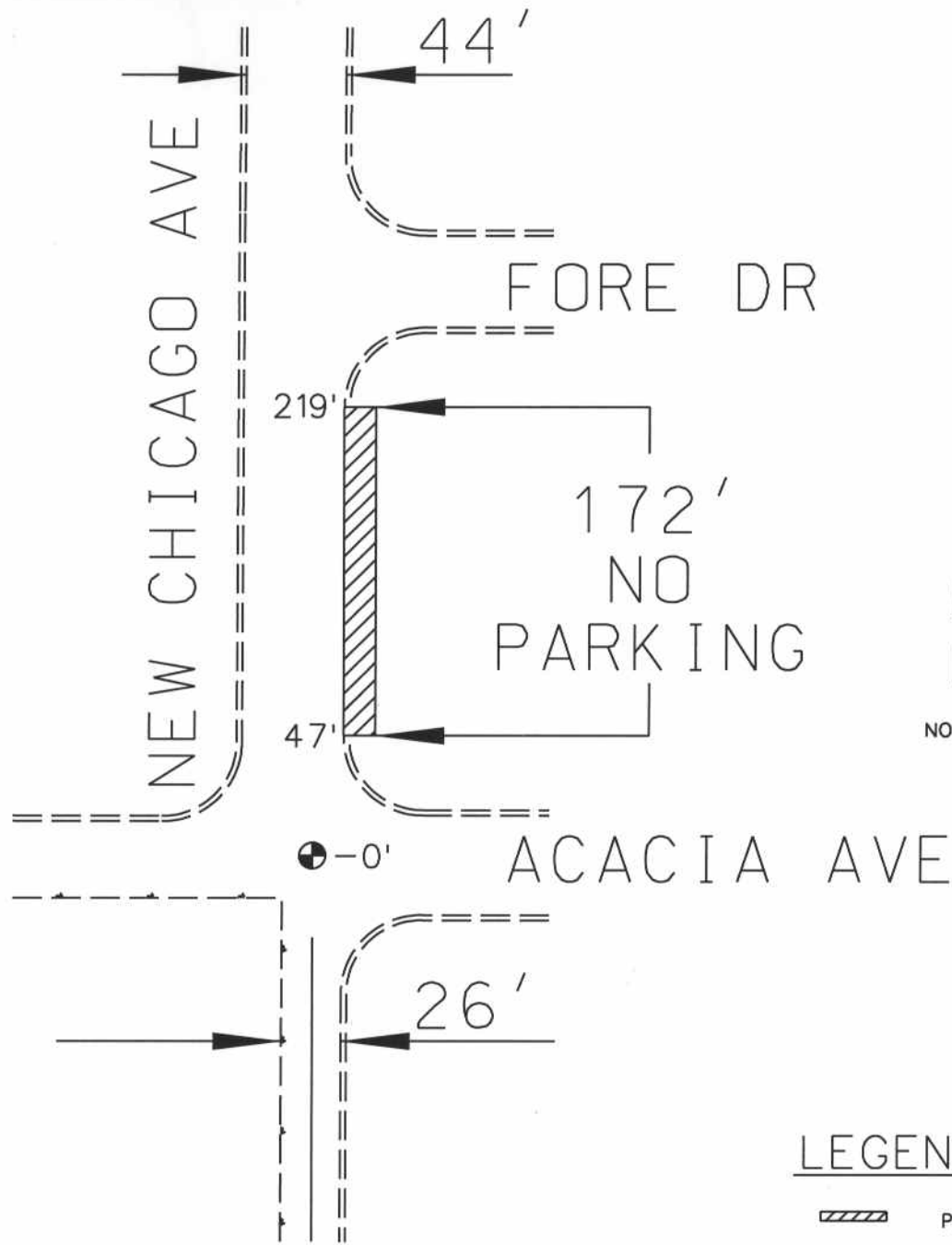
