SUBJECT: Acceptance of a Memorandum of Agreement for the County's Participation in the Office of Drug Control Policy's National Marijuana on Public Lands Initiative

RECOMMENDED MOTION: Move that the Board of Supervisors:

1. Approve and accept a Memorandum of Agreement (MOA) with the U.S. Forest Service, pursuant to a Office of Drug Control Policy (ONDCP) grant to the San Diego Police Department, for the County's participation in the National Marijuana on Public Lands Initiative (NMPL), and authorize the Sheriff to sign the MOA on behalf of the Board.
2. Approve and direct the Auditor-Controller to make the budget adjustments on the attached Schedule A.

**BACKGROUND:** The ONDCP has awarded a High Intensity Drug Trafficking Area (HIDTA) grant to the San Diego Police Department to provide for the National Marijuana on Public Lands Initiative via the California Border Alliance Group on behalf of the United States Forest Service.

This Agreement will authorize the reimbursement of \$25,000 in departmental overtime costs for time devoted to the eradication of marijuana on public lands, National Forest Lands. This is a multi-year agreement, which is contingent upon the continued HIDTA funding. County Counsel as approved the MOA as to form.
