6 BE IT FOUND, DETERMINED, RESOLVED AND ORDERED by the Board of
7 Supervisors of the County of Riverside, State of California, in regular session assembled on
8 August 26, 2003, that pursuant to Sections 29100 through 29103 and 29106 of the California
9 Government Code, that the tax rates for the property on the 2003-2004 secured tax roll be
10 fixed as set for in the schedule hereto attached (the "Schedule"), and that such tax rate for the
11 County of Riverside, the County School Districts, the cities and Special Districts for the Fiscal
12 Year 2003-2004 are hereby adopted.

13 BE IT FURTHER RESOLVED that the levy of the taxes on the property on the secured
14 tax roll be made for the County of Riverside, the County School Districts, the Cities and the
15 Special Districts for the Fiscal Year 2003-2004 in accordance with the tax rates on the
16 Schedule.
