Departmental Concurrence

BACKGROUND: The agreement with Inland Counties Legal Services covering the period July 1, 2003 through June 30, 2004, in the reimbursable amount of \$77,414 continues the provisions of Legal Assistance to the seniors of Riverside County.

Legal Assistance consists of legal representation by a member of the California State Bar or by a non-attorney under the supervision and control of a member of the California State Bar to ensure the rights and entitlements of the seniors by providing or securing legal assistance.

BACKGROUND: (continued)
