SUBJECT: Ratify the Renewal Agreement, with Family Service Association of Western Riverside County FY 2003/04 for Caregiver Program.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the attached renewal agreement with Family Service Association of Western Riverside County.
- 2) Authorize Chairman of the Board to sign the agreement.
- 3) Direct the Clerk of the Board to retain one (1) original copy and return two (2) copies to the Office on Aging for further processing.

BACKGROUND: The agreement with Family Service Association of Western Riverside County, covering the period July 1, 2003 through June 30, 2004, in the reimbursable amount of \$50,000, continues the Caregiver Program to Riverside County seniors of the First, Second, Third, and Fifth Districts. Other contracts cover the Fourth District.

The caregiver program targets, both caregiver and care receivers, in Riverside County, especially those in hard to reach or underserved populations. Assistance in the form of counseling, support groups, training, and respite care.

BACKGROUND: (continued)

The Office of County Counsel has approved this agreement as to form.
