
RECOMMENDED MOTION: That the Board of Supervisors:

- 2) Authorize Chairman of the Board to sign the agreement.
- 3) Direct the Clerk of the Board to retain one (1) original copy and return two (2) copies to the Office on Aging for further processing.

BACKGROUND: The agreement with Developing Aging Solutions with Heart, Inc. covering the period July 1, 2003 through June 30, 2004, in the reimbursable amount of \$ 17,302 continues the Adult Day Care Programs to Riverside County seniors of the First, Third and Fifth Districts. Other Districts are covered by other contracts.

The Adult Day Care Program Allows Riverside County seniors to maintain optimal capacity for self-care and continue to live in the community, rather than being placed in a long term care institution.

BACKGROUND: (continued)
