**SUBJECT:** Ratify the Renewal Agreement, with Inland Caregiver Resource Center FY 2003/04 for Caregiver Program covering all of Riverside County.

**RECOMMENDED MOTION:** That the Board of Supervisors:

- 1) Ratify the attached renewal agreement with Inland Caregiver Resource Center.
- 2) Authorize Chairman of the Board to sign the agreement.
- 3) Direct the Clerk of the Board to retain one (1) original copy and return two (2) copies to the Office on Aging for further processing.

**BACKGROUND:** The agreement with Inland Caregiver Resource Center, covering the period July 1, 2003 through June 30, 2004, in the reimbursable amount of \$175,000, continues the Caregiver Program for all of Riverside County.

The caregiver program targets, both caregiver and care receivers, in Riverside County, especially those in hard to reach or underserved populations. Assistance in the form of counseling, support groups, training, and respite care.
