1 Controller, are as set out on the report of the County Assessor
2 accompanying the notice of public hearing given in consideration of
3 the adoption of this ordinance. For assessment rolls subsequent to
4 1993-94, the County Assessor shall submit a report identifying each
5 timeshare project in which separate assessments that are subject to
6 the fees established herein have been made to the Board
7 of Supervisors at a regularly scheduled meeting of the Board on or
8 before August 15 of each year. On receipt and filing of the
9 report, the County Auditor-Controller shall levy the indicated fees
10 on the assessment numbers as reported by the Assessor. For 1993-94
11 and years thereafter, the fees shall be billed and collected along
12 with the regular taxes and assessments related to each timeshare
13 project separate assessment and shall be subject to the same
14 delinquency penalties and interest otherwise applicable to the
15 regular taxes and assessments. When collected, the fees and any
16 applicable penalties and interest shall be deposited into the
17 County general fund.

18 Section 5. Severability. If any clause, provision,
19 sentence, or paragraph of this ordinance, or the application
20 thereof, is deemed to be invalid as to any person, entity,
21 establishment, or circumstance, such invalidity shall not affect
22 the other provisions of this ordinance which shall still be in
23 effect, and, to this end, it is hereby declared that the provisions
24 of this ordinance are severable.
