**AN ORDINANCE OF THE COUNTY OF RIVERSIDE AMENDING
ORDINANCE NO 725, ESTABLISHING PROCEDURES AND
PENALTIES FOR VIOLATIONS OF RIVERSIDE COUNTY ORDINANCES
AND PROVIDING FOR RECOVERY OF COSTS REASONABLY
RELATED TO ENFORCEMENT**

The Board of Supervisors of the County of Riverside, State of California, ordains as follows:

Section 1. Subsection e., subdivision 1) of Section 1 of Ordinance No. 725 is amended as follows:

Subsection E.1. of Chapter 1.16.010 of the Riverside County Code is amended as follows:


