BACKGROUND:

Departmental Concurrence

In accordance with California Elections Code Sections 307 and 15301, the official canvass of votes for the October 7th Statewide Special Election has been completed and is forwarded for acceptance by the Board.

Of the 659,647 eligible registered voters, turnout was 412,964 or 62.60%. Of this total, 19.13% were cast by absentee ballots.
