After evaluating the Department's needs and the contractor's performance, the Department of Mental Health decided to renew this contract.

SUBJECT: Approval of Fiscal Year 2003/04 Contracts with Tenet Health Systems
Desert, Inc., All Districts.

BACKGROUND: Continued.

The Department of Mental Health is requesting to renew the contract with Tenet Health Systems Desert, Inc. for FY 2003/2004 for indigent acute inpatient services for adults and to contract with them as a participating hospital under the Local Managed Mental Health Care Plan (LMMHCP).

Indigent Services: As a contractor providing indigent services, the contractor will provide 193 units of service this fiscal year for a contract maximum of \$99,084. Specific services include: psychiatric evaluation and treatment services; routine medical evaluations; education; room and board; and all necessary hearings and written reports. All services will be authorized by the County and are limited to persons referred by the County.

Please note that this agreement is now being submitted for Board approval as the Department just completed negotiations with Tenet Health Systems Desert, Inc.

There are sufficient funds in the Department's budget for Fiscal Year 2003/04 to provide for this contract and no additional County funds are required.
