SUBJECT: APPOINTMENT OF SPECIAL DISTRICT DIRECTORS

RECOMMENDED MOTION: That the Board appoint the qualified candidates as directors for the respective Districts and terms as shown on the attached Exhibits A and B.

BACKGROUND: The Registrar of Voters certifies that the individuals recommended for appointment are qualified candidates for the office stated, having duly filed the required documents for nomination to the respective office or having been recommended by the District.

Due to insufficient nominees, the August 26, 2003 Uniform District Election (UDEL) was not held for the election contests listed on Exhibit A. Further, the November 4, 2003 UDEL was not held for the election contests listed on Exhibit B due to insufficient nominees.

Pursuant to Election Code Section 10515, the Board of Supervisors shall appoint any person so nominated prior to the Monday before the first Friday in December.

Idyllwild Fire Protection District and So. Coachella Valley Community Services have vacant seats; therefore, pursuant to California Elections Code 10515(b) the supervising authority (Board of Supervisors) shall appoint a qualified person(s) to the office.
