SUBJECT: Ratification of the Consent to Assignment of Beverly Manor to Riverside Sanitarium, LLC, DBA Country Villa Riverside Healthcare Center

BACKGROUND: (Continued)

Beverly Manor is an Institute for Mental Disease (IMD) facility. An IMD facility is a State licensed Skilled Nursing Facility (SNF) with a special treatment program, serving clients within the age range of 18-64. Treatment services include: Self-help skills training, behavioral intervention training, inter-personal relationships, pre-vocations preparation services (i.e. homemaking, work activity and vocational planning) and discharge planning. This program provides an alternative to State hospitalization. The purpose of this program is to establish a level of understanding and wellness in clients to enable their movement into a lower level of care or self-sufficient level of care.

Beverly Enterprises, Inc. has chosen to vacate the State of California. In doing so all assets in this state were sold to various organizations. The Beverly Manor IMD facility has been sold to Country Villa Riverside Healthcare Center effective October 1, 2003 coinciding with the approval of Country Villa Riverside Healthcare Center Medi-Cal certification for the location.

Beverly Manor is one of three facilities in the area that provides IMD services to the Riverside County Department of Mental Health. The approval of the Consent to Assignment will allow Riverside County Department of Mental Health to maintain the current level of treatment provided, reducing the need for State hospitalization services.
