**SUBJECT:** Approve Transfer of Occupied Development Specialist I position from EDA to TLMA Building and Safety Department. and amend Ordinance 440 pursuant to Resolution No. 440-8525.

**RECOMMENDED MOTION:** That the Board of Supervisors:

1. Approve the transfer of Development Specialist I position control number 73822 and incumbent from Economic Development Agency to TLMA Building & Safety Department,
2. Approve the amendment to Ordinance 440 pursuant to Resolution No. 440-8525

**BACKGROUND:** One Development Specialist I position, with current incumbent, is needed to facilitate voluntary compliance with county building, land use and related codes in the Desert region of the county. This position will report to the TLMA Desert Regional Office Manager, and will initially work with owners and residents of substandard mobile home parks in identifying the resources and benefits of achieving voluntary compliance with building and land use codes. The Economic Development Agency and TLMA Building & Safety Department are in agreement that this transfer is in the best interest of the County. To fund this requested Development Specialist I position the department will defund one budgeted vacant Code Enforcement Officer II position.
