BACKGROUND: Tentative Tract No. 28582 is mapping over this portion of Glencoe Lane creating a cul-de-sac on its easterly end prior to an intersection with Palomar Road. This portion of Glencoe Lane will no longer join Glencoe Lane easterly of Palomar Road. The developer of Tentative Tract No. 28582 and the adjacent property owner have requested and consent to this name change. No other property owners are affected by this name change. The Transportation Department recommends approval of this name change.

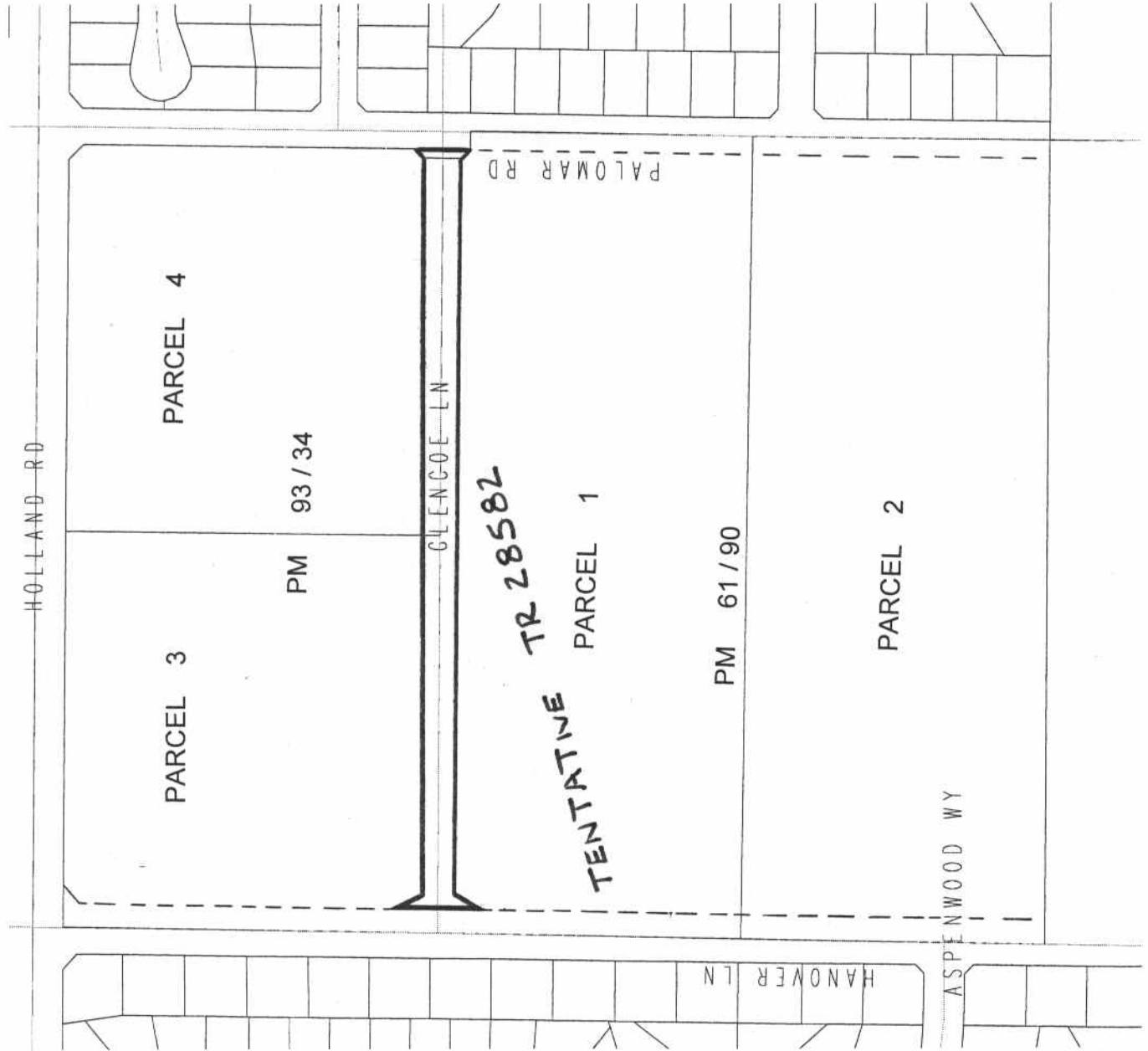

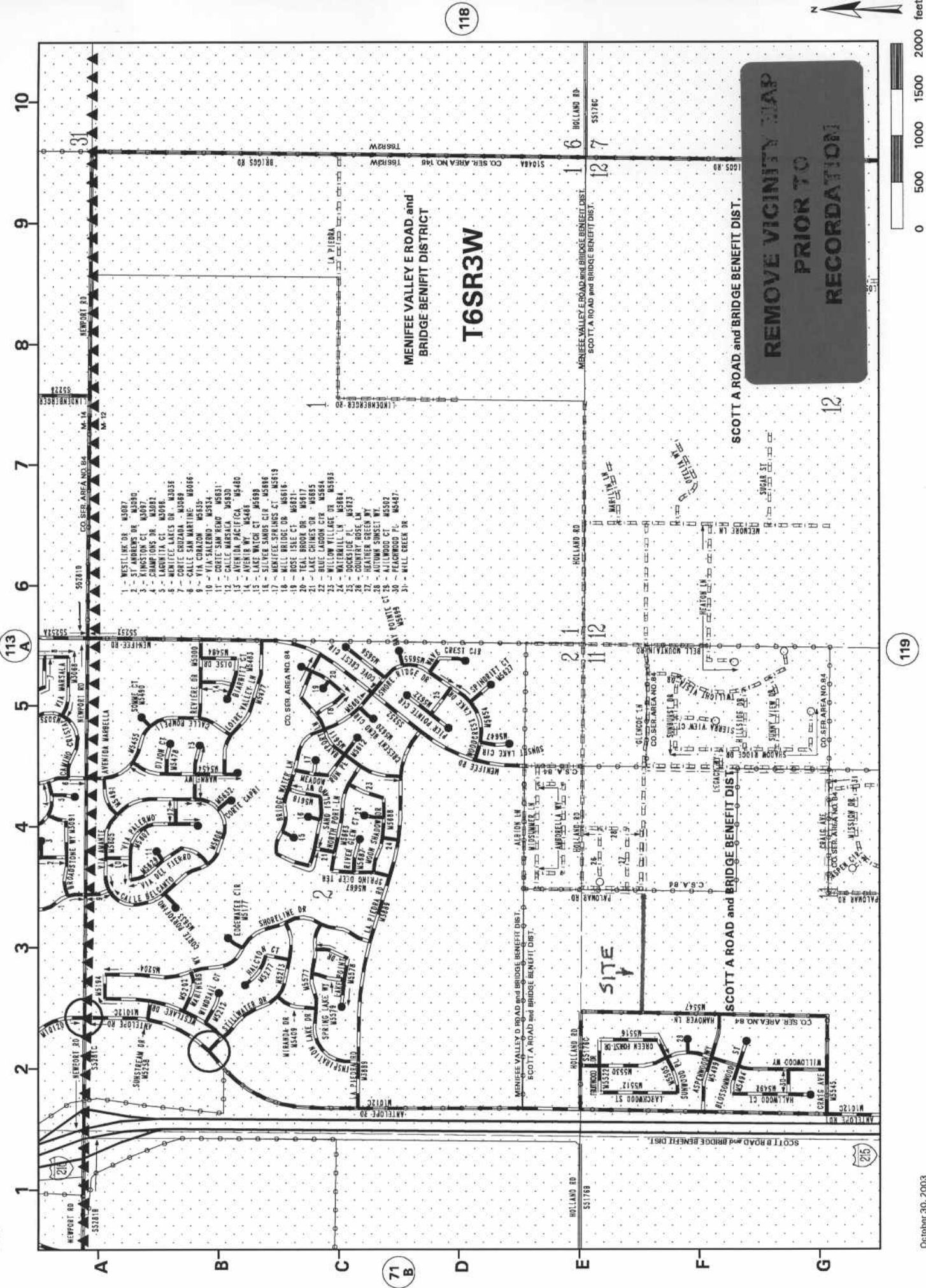
