SUBJECT: First Amendment to Professional Medical Services Agreement between the County of Riverside and Loma Linda University Surgery Medical Group

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the Amendment to the Agreement with Loma Linda University Surgery Medical Group and Riverside County Regional Medical Center (RCRMC), effective December 1, 2003;
- 2) Authorize the Chairman to execute the Amendment;
- 3) Direct the Clerk of the Board to retain one (1) original and return two (2) original copies of the Amendment to RCRMC - Contract Administration.

BACKGROUND: On December 11, 2001, Agenda Item No. 3.33, the Board of Supervisors approved the contract with Loma Linda University Surgery Medical Group for the provision of Hyperbaric Oxygen Therapy/Wound Care Professional Services. This Amendment extends the term of the Agreement for a period of one year, with the option to renew for two additional years. In addition, the required Health Insurance Portability and Accountability Act Compliance Language is added to the Agreement through the Amendment. The monthly compensation to Loma Linda University Surgery Medical Group will remain the same with these changes to the Agreement.

Riverside County Council has approved this Amendment as to form.
