**RECOMMENDED MOTION:** That the Board of Supervisors adopt Resolution No. 2004-032 Notice of Intent to Change the Name of Verbenia Avenue, from Railroad Avenue northerly and westerly to its terminus, to Haugen-Lehmann Way, in the Whitewater area.

**BACKGROUND:** On January 5, 1997, on Verbenia Avenue, in the Whitewater area of Riverside County, Deputy Sheriffs Michael Haugen and James Lehmann Jr. were slain in the line of duty. As a tribute to their sacrifice, Sheriff Doyle requests that the Board approve this proposal to rename Verbenia Avenue as Haugen-Lehmann Way.

19 and consider the proposal to change the name and any objections thereto.

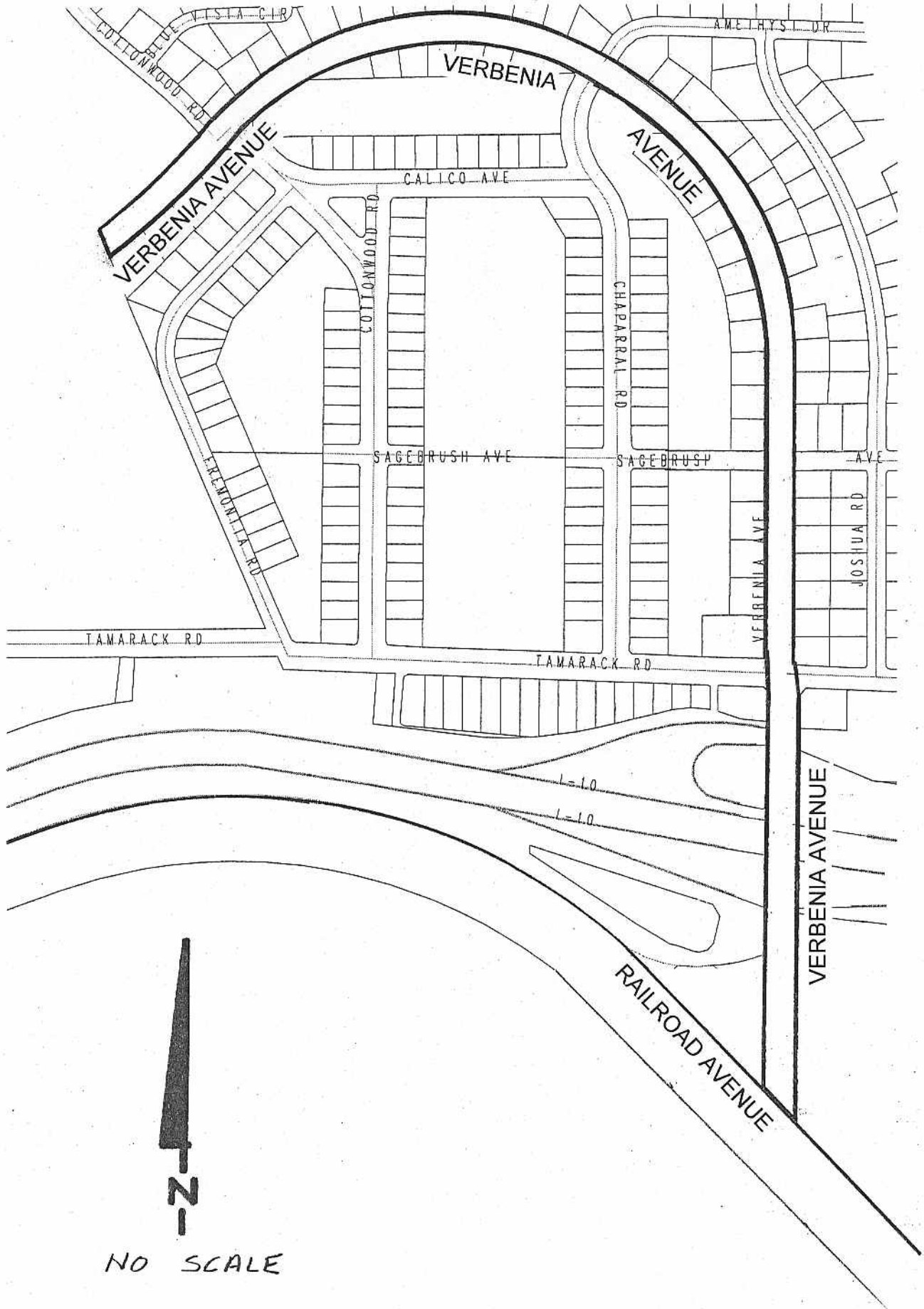

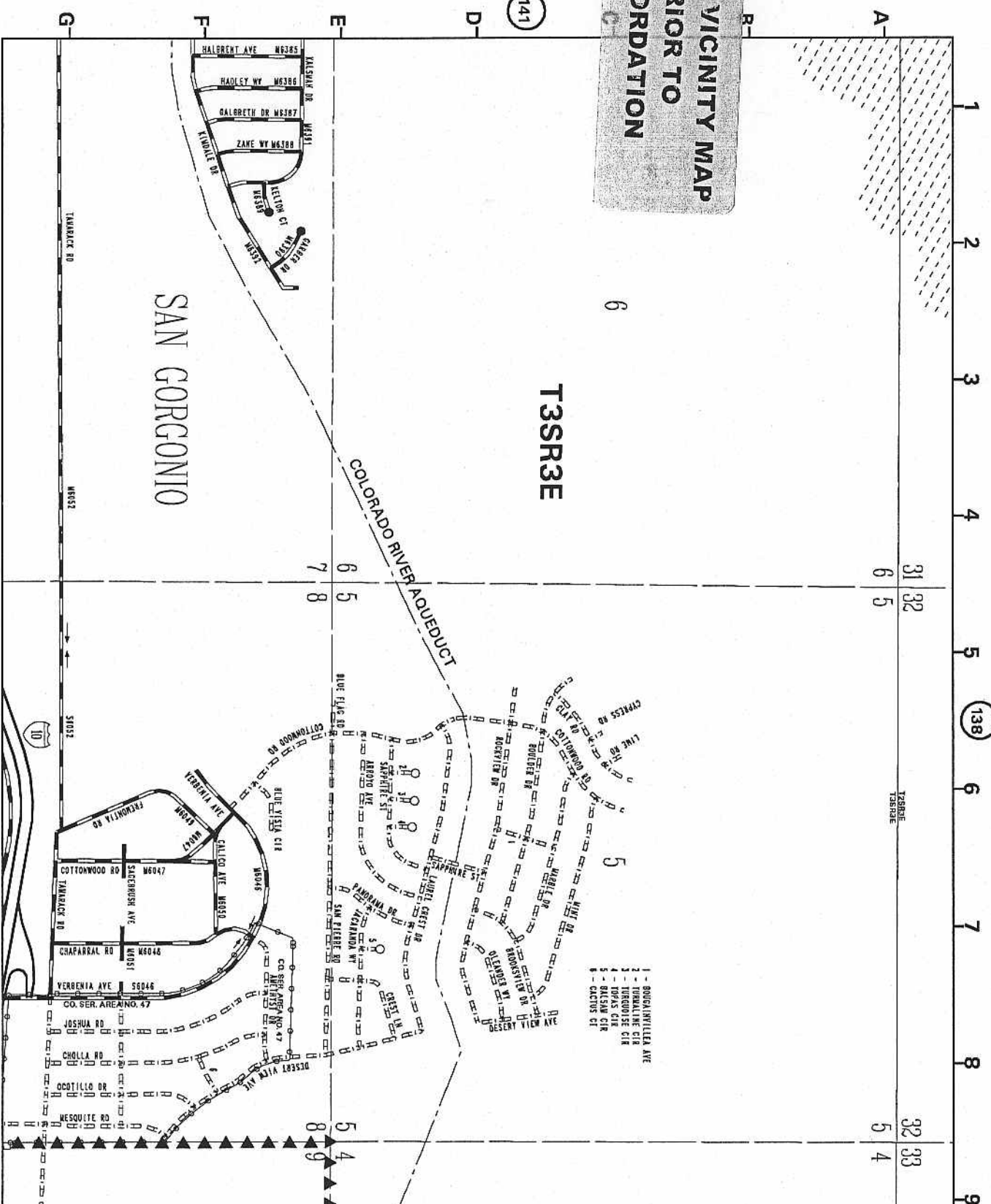
