**SUBJECT:** Ratify Fourth Amendment to the Agreement #02-256A-4, Ryan White Comprehensive AIDS Resources Emergency (CARE) Act Services, with County of San Bernardino, Department of Public Health for dental care.

**BACKGROUND:** (Continued)

The Ryan White CARE Act was enacted in 1990 to provide federal funding for comprehensive health and social services for persons living with the Human Immunodeficiency Virus (HIV). The Federal Health Resources and Services Administration (HRSA) provides funding through Title I of the Ryan White CARE Act to geographic areas disproportionately affected by the HIV epidemic. Funds from this Agreement will be used by the Riverside County Regional Medical Center to provide dental care for people living with HIV.

**FINANCIAL DATA:** Expenditures are fully reimbursed by the Ryan White CARE Act through the County of San Bernardino with no impact on County of Riverside General Funds. This funding is included in the Community Health Agency, Department of Public Health Fiscal Year 2003/2004 budget.
