15 that said road is a public road open for use by the general public;

18 is for the purpose of vesting title in the County of Riverside on behalf of the public, for public  
19 road and utility uses and is not an acceptance of the road into the County Maintained Road  
20 System pursuant to Section 941 of the Streets and Highways Code and that said road shall  
21 not become a part of the County Maintained Road System unless subsequently accepted into  
22 said maintained road system by resolution adopted by this Board;

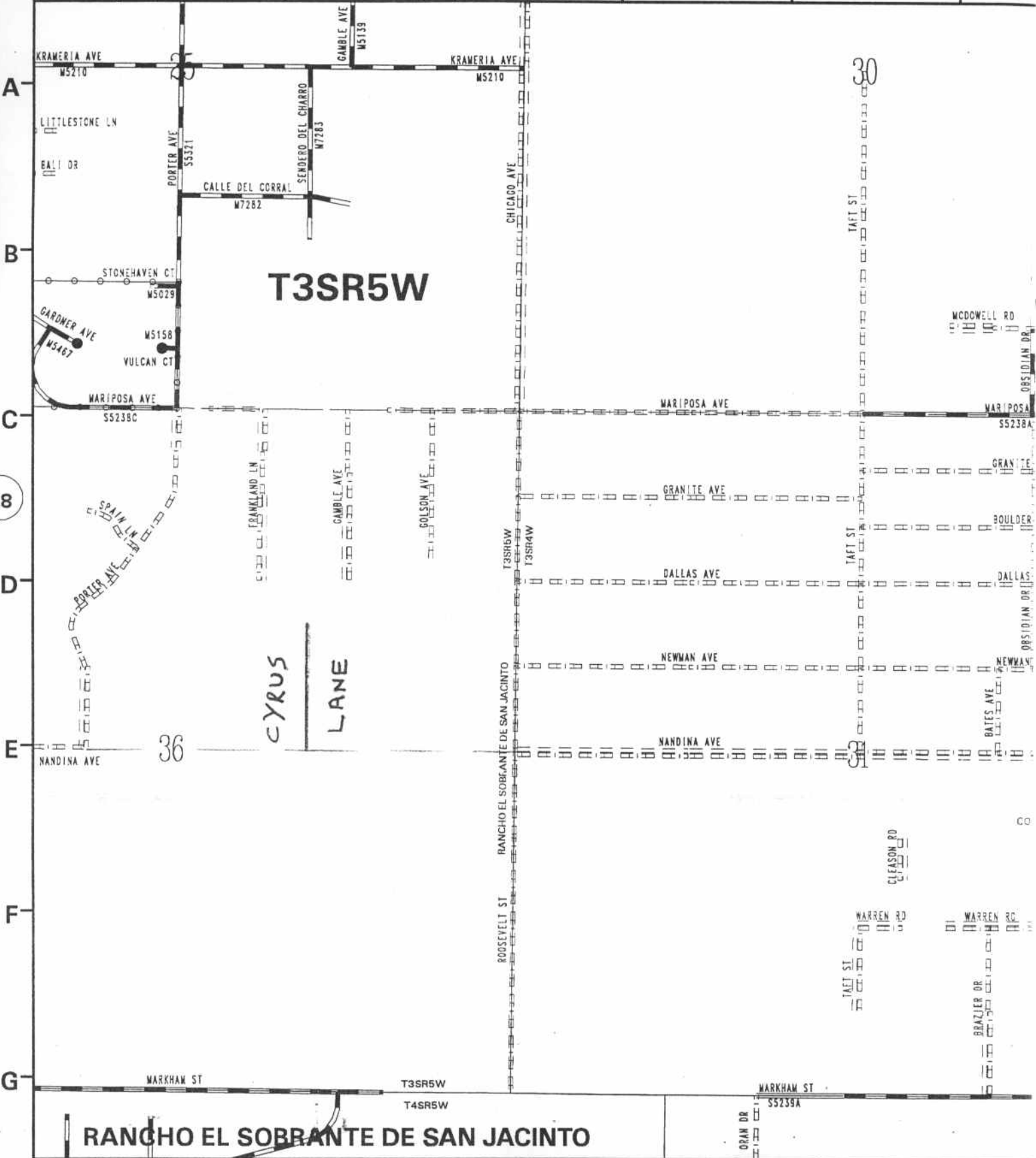
