8 **WHEREAS**, the hereinafter-described Redtail Lane was offered for dedication for
9 public road and utility purposes by the map and document herein-after referred to, which
10 offers of dedication have not previously been accepted by the County, now, therefore,

13 **BE IT RESOLVED, DETERMINED AND ORDERED** by the Board of Supervisors of
14 the County of Riverside, State of California, in regular session assembled on _____
15 January 27 , 2004, that this Board accepts the offers of dedication and recognizes
16 that said road is a public road open for use by the general public;

18 **BE IT FURTHER RESOLVED, DETERMINED AND ORDERED** that this acceptance
19 is for the purpose of vesting title in the County of Riverside on behalf of the public, for public
20 road and utility uses and is not an acceptance of the road into the County Maintained Road
21 System pursuant to Section 941 of the Streets and Highways Code and that said road shall
22 not become a part of the County Maintained Road System unless subsequently accepted into
23 said maintained road system by resolution adopted by this Board;

25 Said road is in the County of Riverside, State of California, and is described as follows:

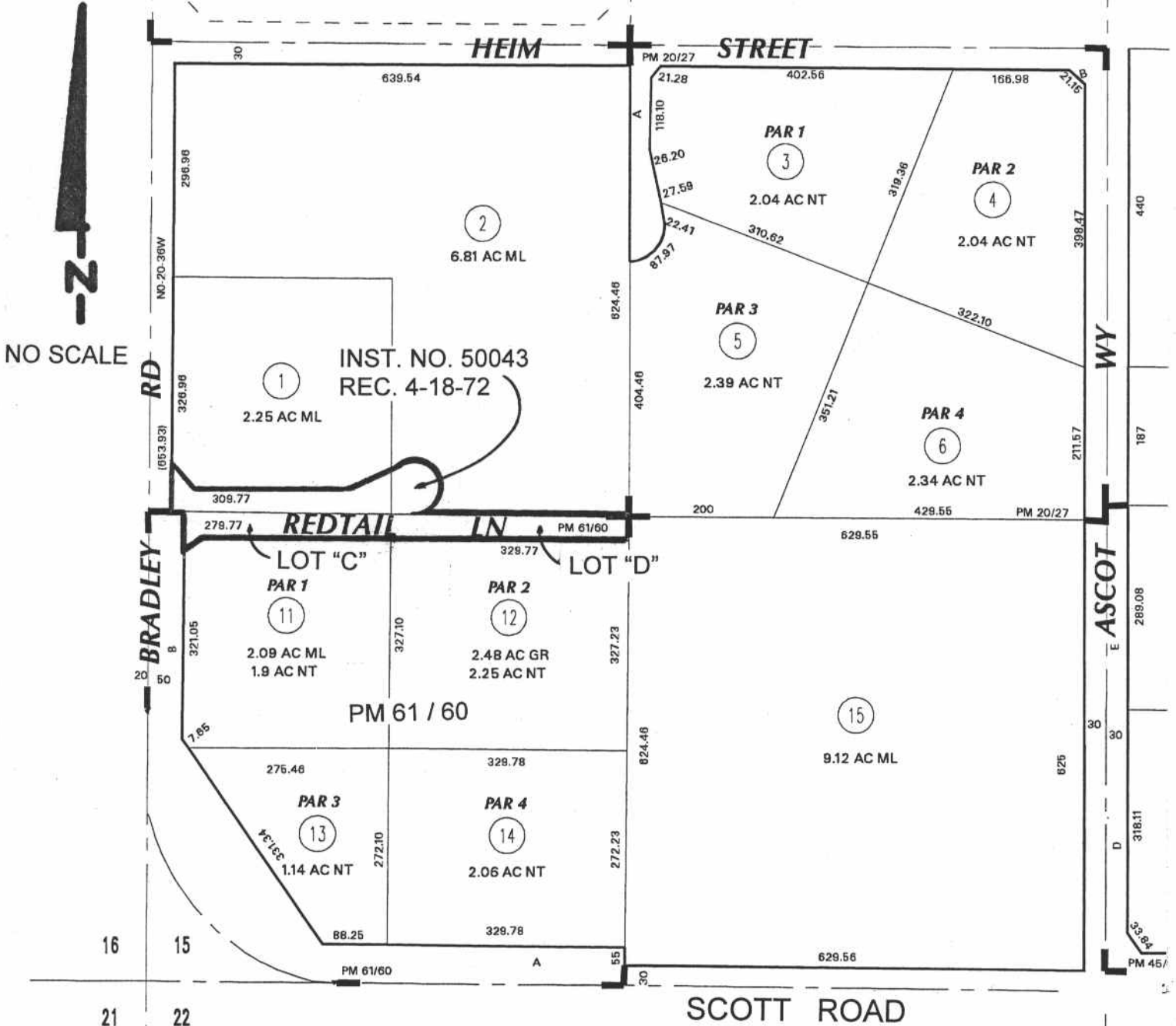
