Eligibility: Public Service 570.201 (e), Code – 03T
Benefit: Low/Mod Clientele 570.208 (a)(2)(i)(B)
Sponsor: Red Cross of Eastern Riverside County
Address: 41-951 Corporate Way, Palm Desert, CA 92253

Project Description: CDBG funds will be used to cover program expenses for recovery costs associated with natural disasters, fires, and other emergencies that displace low/mod income families. Eligible activities include but are not limited to temporary housing assistance, food vouchers, clothing, and transportation.

Project: Ripley Water System Improvements
Eligibility: Public Facility 570.201 (c), Code – 03J
Benefit: Low/mod Area 570.208 (a) (1) (i)
Sponsor: Economic Development Agency-County Service Area 62
Address: School Road, Ripley, CA 92225

Project Description: CDBG funds will be used to pay cost associated with the design, engineering, and construction of water system improvements in the community of Ripley. The improvements are necessary to meet primary and secondary water quality standards. The improvements include iron-manganese treatment and reverse osmosis.
