AN ORDINANCE OF THE COUNTY OF RIVERSIDE AMENDING
ORDINANCE NO. 460 RELATING TO SUBDIVISIONS

The Board of Supervisors of the County of Riverside Ordains as follows:

Section 1. Subsection J(14) of Section 10.25 of Ordinance No. 460 is amended to read as follows:

(14) Anza ADP \$2,198 per acre.

Section 2. This ordinance shall take effect 60 days after the date of adoption.

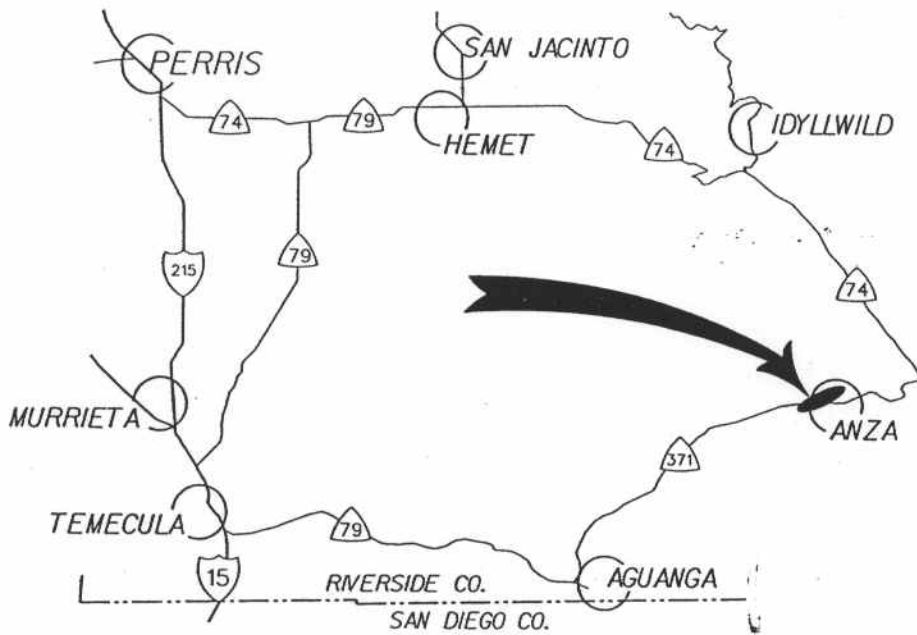

ANZA AREA DRAINAGE PLAN

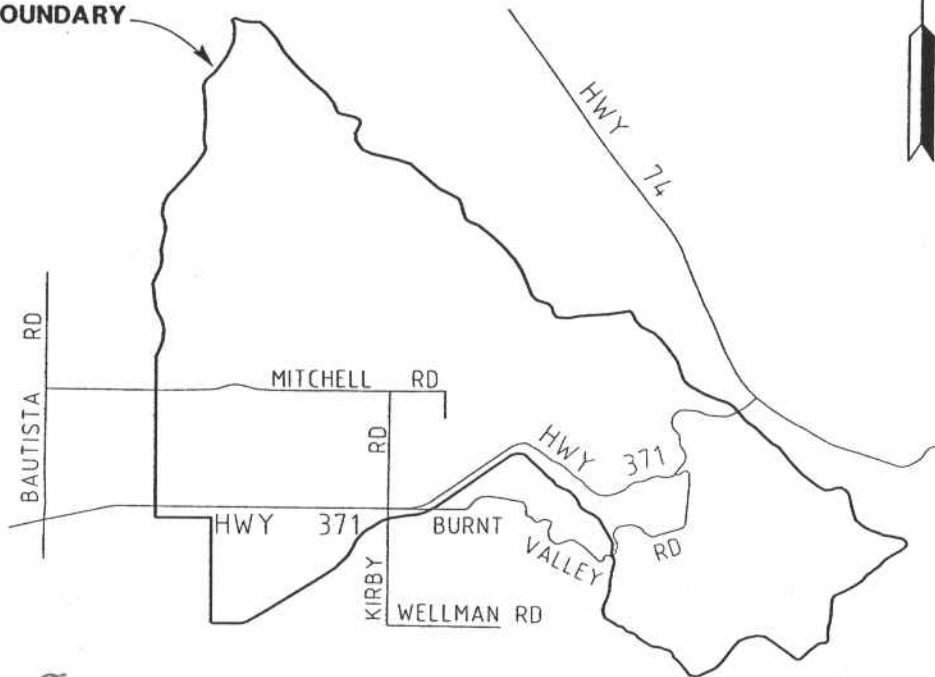


VICINITY MAP

RECOMMENDED MOTION:

Adopt Resolution No. 2004-002 adopting Amendment No. 2 to the Anza Area Drainage Plan and Ordinance No. 460.143.

BACKGROUND:

Pursuant to Resolution 88-164 adopting the Anza Area Drainage Plan (ADP), the Flood Control District was directed to prepare and update the plan at least every two years.

The recommended fee increase, from \$1,810 per acre to \$2,198 per acre, for the Anza Area Drainage Plan is due to inflationary trends in construction and right-of-way costs. The estimated construction cost is based on 2003 unit prices developed from public works projects administered by the District. Estimated right-of-way costs are based on recent property sales records for the Anza area.
