SUBJECT: Amendment to Designated Positions Listings for County Conflict of Interest Code.

RECOMMENDED MOTION:

- (1) That the Board of Supervisors set a public hearing for March 2, 2004 on amendments to the Conflict of Interest Code for the County of Riverside (Clerk to advertise)
- (2) That at the close of the public hearing the Board adopt the revised listings of Designated Positions in the Code.

BACKGROUND: Government Code Section 87100 *et seq.*, require that each governmental agency adopt and maintain a Conflict of Interest Code. Since 1986, the County has been using the standard Conflict of Interest Code found in California Code of Regulations, Title 2, Section 18730.

Generally, Government Code Section 87306.5 requires that in every even numbered year, all local agencies review their codes and make any appropriate amendment to their conflict of interest codes, and the listing of designated positions for the employees who must disclose along with the types of disclosure required. On October 22, 2002, the Board adopted the revised listings of Designated Positions pursuant to §87306.5.

However, §87306.5 does not prohibit more frequent amendments. In order to maintain our code as current as possible, the Board is being asked to approve the attached corrections/amendments for the Assessor-County Clerk-Recorder and the Riverside County Regional Medical Center (RCRMC).
