SUBJECT: Renew Training Agreement with Riverside Community College District.

RECOMMENDED MOTION: Move that the Board approve and authorize the Chairman to sign the attached agreement with Riverside Community College to provide Fire Technology Program Services.

BACKGROUND: On February 3, 1998 (M.O. 3.14) the Board approved an agreement between the Riverside Community College District (RCCD) and Riverside County Fire Department to provide the training of Riverside County Fire Personnel at the Clark Public Safety Training Center. The new agreement extends the terms of the contract for 5 years ending June 30, 2008.

Departmental Concurrence

Approximately 413 training classes were held last year at the Clark Public Training Center with over 12,000 students participating in the various public safety and emergency services programs. RCCD is responsible for program services and as such will provide faculty orientation, instructor manuals, course outlines, curriculum materials, testing and grading procedures and any other services it provides to hourly instructors in the District. RCCD also reserves the right to determine maximum class size and course credit and is responsible for processing student applications and enrolling students in the Academy. Instructors will be provided by the Fire Department and work under the supervision and control of a District employee. RCCD will pay the Fire Department for the services of these instructors at the prevailing faculty rate in effect during the time the Fire Academy is in progress.
