BACKGROUND: Adoption of Resolution No. 2004-117 appoints the Director of the Transportation Department as the Engineer to prepare a Report regarding the proposed annexation of Street Lighting Zone 10 to Landscaping and Lighting Maintenance District No. 89-1-Consolidated ("L&LM District No. 89-1-C").

Resolution No. 2004-118 declares the Board's intention of ordering the annexation of Street Lighting Zone 10 to L&LM District No. 89-1-C. Annexation of Street Lighting Zone 10 to L&LM District No. 89-1-C will fund providing electricity for streetlights within public rights-of-way located easterly of Hamner Avenue and northerly of Limonite in the Mira Loma area and includes 10 commercial parcels totaling 26.01 acres.

The proposed budget of fiscal year 2004-05 for Street Lighting Zone 10 is \$1,277.34 that will result in an assessment for fiscal year 2004-05 within Street Lighting Zone 10 of \$49.10 per acre. The annual assessment will be adjusted annually by the greater of 2% or the cumulative percentage increase in the CPI-U for "electricity", if any, as it stands as of March of each year over the base index for March of 2004.

Consistent with the Board's direction regarding compliance with Article XIID of the California Constitution and the Landscaping and Lighting Act of 1972, the attached resolutions have been prepared and a public hearing scheduled for 9:30 a.m. on May 4, 2004 to receive testimony for and against the proposed assessment. Each property owner within the proposed Street Lighting Zone 10 will receive a notice of the public hearing and mail-in ballot, an impartial analysis, a copy of Resolution No. 2004-118 and an information sheet.

Ballots must be returned prior to the conclusion of the public hearing. If, at the time designated for the tabulation of the ballots, the weighted ballots submitted in favor of the annexation and levy of the assessment exceed the weighted ballots submitted in opposition of said annexation and levy, Street Lighting Zone 10 will be annexed to L&LM District No. 89-1-C.
