ORDINANCE NO. 735.1

AN ORDINANCE OF THE COUNTY OF RIVERSIDE
ESTABLISHING FEES FOR THE SEPARATE ASSESSMENT
OF TIMESHARE PROJECTS

The Board of Supervisors of the County of Riverside, Ordains as follows:

Section 1. Section 3 of Ordinance No. 735 is hereby amended to read as follows:

The following fees shall be charged for each timeshare project separate assessment made by the County Assessor under Revenue and Taxation Code sections 2188.8 and 2188.9:
