SUBJECT: LPS DESIGNATION OF FACILITY FOR INVOLUNTARY DETENTION OF MENTALLY DISORDERED PERSONS FOR EVALUATION AND TREATMENT. DISTRICT 1.

RECOMMENDED MOTION: Move that the Board of Supervisors:


1. Designate the Moreno Valley Community Hospital, 30-bed inpatient psychiatric unit, 27300 Iris Avenue, Moreno Valley, California 92555 as a facility for 72-hour treatment and evaluation pursuant to California Welfare & Institutions Code, Section 5150 et. seq.
2. Authorize the Director of Mental Health to submit the request to the State Department of Mental Health as required by Section 800 et. seq., Title 9, California Code of Regulations.

BACKGROUND: The Department of Mental Health's Inpatient Quality Improvement and Patients' Rights sections have conducted a review of the Moreno Valley Community hospital and have found the program to be in compliance with the criteria for designation. We are, therefore, requesting that the Board designate the 30-inpatient psychiatric beds, under the general acute care license of the Moreno Valley Community Hospital as a facility for involuntary detention of mentally disordered persons for evaluation and treatment.
