SUBJECT: HOUSING AND URBAN DEVELOPMENT RENEWAL GRANT AGREEMENT—MFI RECOVERY CENTER

RECOMMENDED MOTION: That the Board of Supervisors approves and:

1. Authorizes the Chairman of the Board to sign the attached Grant Agreement between Riverside County Department of Public Social Services (DPSS) and the U.S. Department of Housing and Urban Development (HUD) for a Supportive Housing Program (SHP) Grant for \$87,914 for the period of December 1, 2003 through November 30, 2004.
2. Authorizes the Chairman of the Board to ratify and sign the attached Contract, HU 1565 00, between DPSS and MFI Recovery Center;
3. Authorizes the Purchasing Agent to sign amendments to the Contract, not to exceed the maximum contract amount; and
4. Authorizes the Director of DPSS to administer the agreement with MFI Recovery Center.

BACKGROUND:

On June 18, 2002 (Agenda Item 3.69), your Honorable Board authorized DPSS to submit an application for Homeless Assistance funds to the U.S. Department of Housing and Urban Development, which included renewal funding for a supportive housing program operated by MFI Recovery Center. HUD approved the application and allocated \$87,914 for a 1-year period. MFI Recovery Center provides transitional housing and substance abuse services to women and their children.

HUD approved the funding agreement on March 2, 2004, which we are submitting to your Board for approval along with the County's agreement with MFI Recovery to operate the program. HUD has indicated in its Grant Agreement that eligible costs incurred between the expiration of the prior grant on November 30, 2003, and the execution of this Renewal Grant Agreement may be paid with funds from the first operating year of this Renewal Grant.

FINANCIAL DATA: No County General Funds are required.

The budget for the two (2) fiscal years is broken down as follows: Year 1- \$43,957; and Year 2-\$43,957. The total agreement amount is \$87,914.
