SUBJECT: Appointments to the Board of Examiners for Backflow and Cross Connection Control

RECOMMENDED MOTION:

That the Board of Supervisors appoint Greg Spears, Bill Schoenborn, and Mark Abbott to three year terms and Mike Mendoza to a two year term as members of the Board of Examiners for Backflow and Cross Connection Control.

BACKGROUND:

The Board of Supervisors adopted Riverside County Ordinance No. 525.4 effective April 16, 1998. Section 2 of the ordinance established a five (5) member Board of Examiners, appointed by the Board of Supervisors. The members are appointed for three (3) year terms, not to exceed a collective appointment of ten (10) years. Due to term limitations and Department staff reassignments, appointments need to be made for 4 out of the 5 positions.
