**RECOMMENDED MOTION:** That the Board of Supervisors:


- 1) Ratify the attached One Time Only Agreement with Inland Agency.

**BACKGROUND:** Under our agreement with California Department on Aging, One Time Only (OTO) funds can be used for the following purposes:

- Purchase of equipment which enhances the delivery of services to the eligible population
- Home and Community based projects, as approved by CDA
- Innovative pilot projects, as approved by CDA

This agreement with Inland Agency for One Time Only funds in the reimbursable amount of \$2,544, for the purchase of equipment, (Dell 2400 Dimension computer and 1 PC Master computer), will enhance counseling, advocacy and community education for Medicare Beneficiaries in Riverside County.
