SUBJECT: Notice of intention to change the name of Galena Street to Cantu-Galleano Ranch Road in the Mira Loma Area, Second Supervisorial District.

RECOMMENDED MOTION: Adopt Resolution No. 2004-086, Notice of intention to change the name of Galena Street to Cantu-Galleano Ranch Road.

BACKGROUND: This name change is for the portion of Galena Street between Hamner Avenue and the I-15 freeway, which will be constructed as part of the Cantu-Galleano Ranch Road / I-15 interchange project. This portion of Galena Street was not included on the original street name change resolution changing Galena Street east of the I-15 to Cantu-Galleano Ranch Road. Now that the alignment has been determined for the interchange, this portion of Galena Street west of the I-15 should also be named Cantu-Galleano Ranch Road.

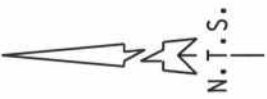
