**SUBJECT:** Approval of Resolution No. 2004-2 Delegating Authority to Accept Donations to the General Manager of the Riverside County Regional Park and Open Space District

**RECOMMENDED MOTION:** That your Board approve the attached Resolution No. 2004-2 and authorize the Chairman to execute same on behalf of your Board.

**BACKGROUND:** The Park District is actively involved with several support groups that provide volunteer services and also raise funds to support its parks, nature centers, and historic facilities. The Gilman Ranch Hands and the Friends of the San Jacinto Mountains County Parks have donated funds to the Park District in the past, and the newly formed Santa Rosa Plateau Foundation is now raising funds to support interpretive programs at the Santa Rosa Plateau Visitor Center.

In order to expedite the acceptance of funds and other gifts offered to the Park District by support groups, County Counsel has prepared the attached Resolution No. 2004-2 that would authorize the General Manager to accept gifts, bequests, or other donations consistent with the provisions of Government Code Section 25355.


8 WHEREAS, the Riverside County Regional Park and Open-Space District

12 Supervisors may delegate to any county officer or employee, the power to accept  
13 any gift, bequest or devise made to the County, and

15 WHEREAS, section 25355 establishes the reporting requirements  
16 associated with the acceptance of such gift, bequest or devise.

18 NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the  
19 Riverside County Regional Park and Open-Space District assembled in regular  
20 session on May 18, 2004, that the General Manager of the DISTRICT is  
21 authorized and empowered to accept donations, consistent with the provisions of  
22 Government Code section 25355.
