SUBJECT: Notice of intention to change the name of Calle Verde to Avenia Verde in the Rancho California Area, Third Supervisorial District.

RECOMMENDED MOTION: Adopt Resolution No. 2004-123, for the notice of intention to change the name of Calle Verde to Avenia Verde in the Rancho California Area.

BACKGROUND: Calle Verde and Avenia Verde were two separate streets ending in cul-de-sacs as shown on Parcel Map Book 3, pages 80 and 81. Additional parcel maps have recorded and dedicated road right of way connecting Calle Verde to Avenia Verde. This name change will create one street name of Avenia Verde for the street between Pauba Road and De Portola Road. Calle Verde is the shortest segment of the road and has only one address issued to Calle Verde. The affected property owner has been notified of this name change and has not responded. There has been no opposition to this name change. The Thomas Brothers Road Guide already identifies this portion of road as to Avenia Verde. The Transportation Department recommends approval of this name change.

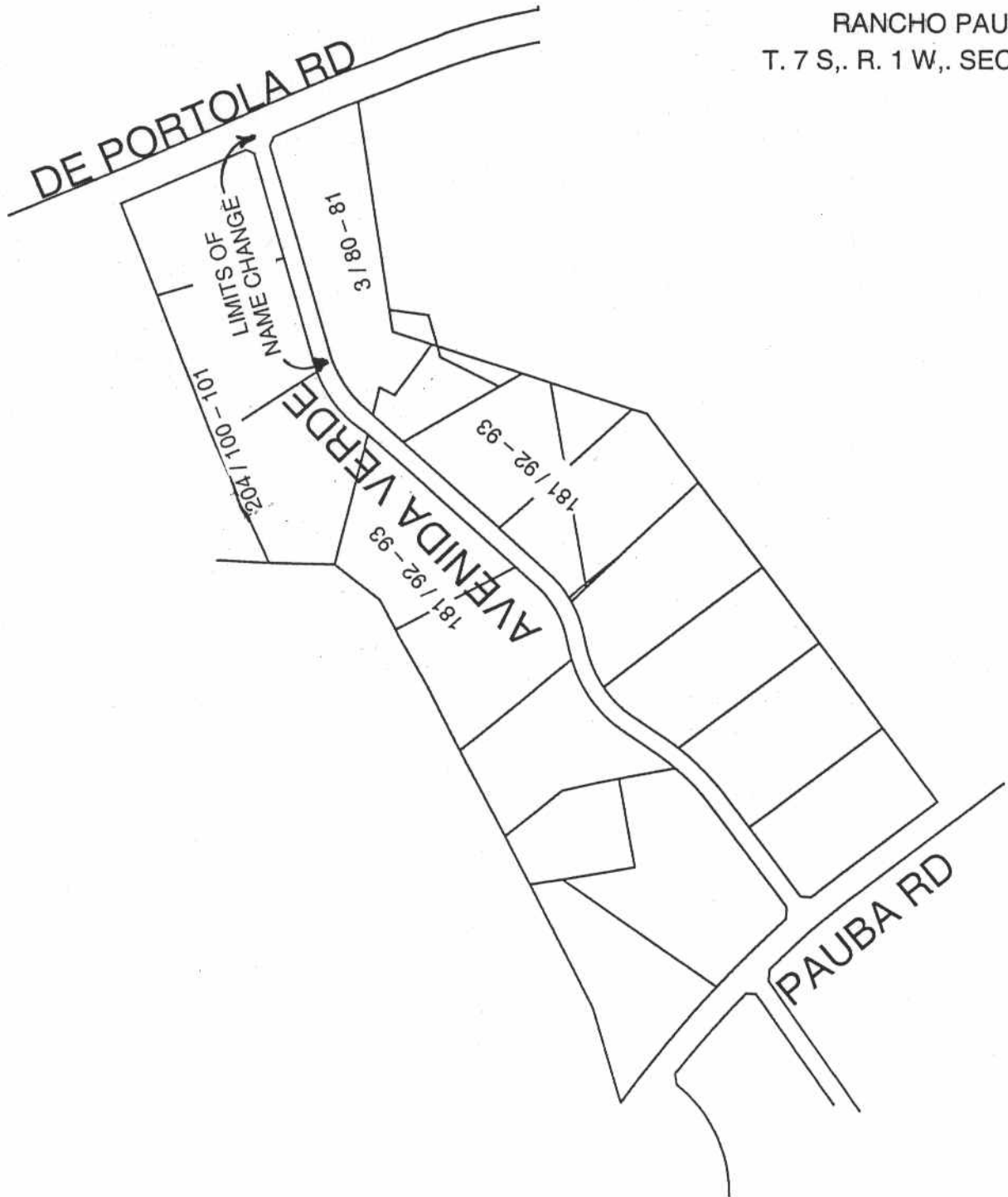

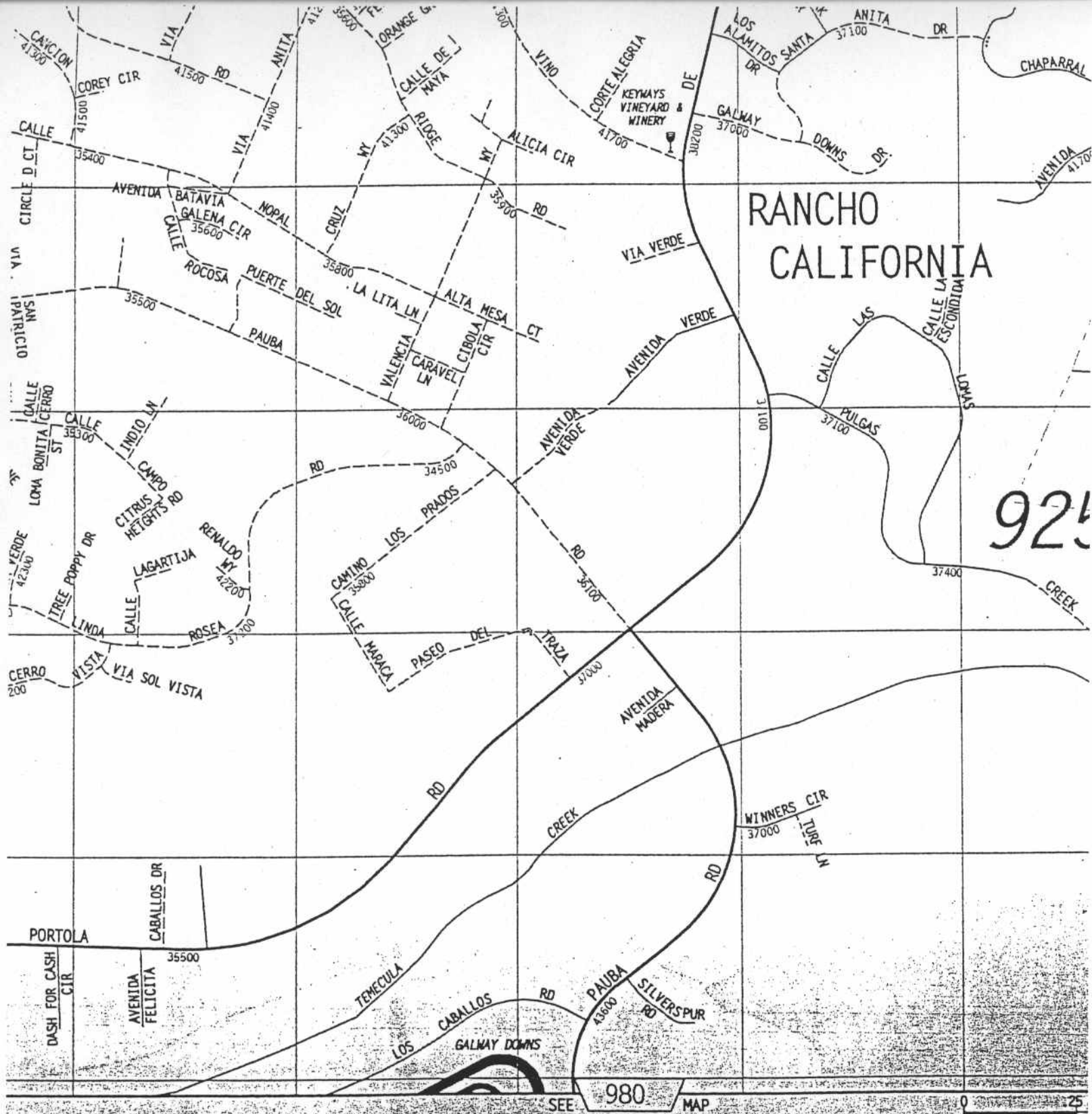
