**SUBJECT: HOUSING AND URBAN DEVELOPMENT RENEWAL GRANT AGREEMENT—HOUSING AUTHORITY OF RIVERSIDE COUNTY**

**RECOMMENDED MOTION:** That the Board of Supervisors approves and:

1. Authorizes the Chairman of the Board to sign the attached Grant Agreement between DPSS and the Housing Authority of Riverside County to run the Shelter Plus Care Project from July 1, 2004 through June 30, 2005, not to exceed \$93,804;
2. Authorizes the Purchasing Agent to sign the Contract and any subsequent ministerial amendments with the Housing Authority, not to exceed the maximum amount of the Grant Agreement (\$93,804) ; and
3. Authorizes the Director of DPSS to administer the agreement with Housing Authority.

**BACKGROUND:**

On July 1, 2003, (Agenda Item 3.49), your Honorable Board authorized DPSS to submit an application for Homeless Assistance funds to the U.S. Department of Housing and Urban Development, which included renewal funding for a shelter plus care program operated by Housing Authority. HUD approved the application and allocated \$93,804 for a 1-year period. Housing Authority provides tenant based rental assistance for homeless mentally ill persons.

HUD approved the funding agreement on May 20, 2004, which we are submitting to your Board for approval.
