RECOMMENDED MOTION:

That the Board of Supervisors approve and authorize the Chairman of the Board to sign the attached Amendment #2 to the GAPP-3047 General Alternative Payment Program Local Agreement for Child Care Services with the California Department of Education (CDE) for Fiscal Year 03/04 to change language in the Fiscal Terms & Conditions (FT&C).

BACKGROUND:

On July 15, 2003 (Agenda #3.44) and November 25, 2003 (Agenda #3.38), the Board approved the GAPP-3047 Child Care General Alternative Payment Program Local Agreement and Amendment between CDE and Riverside County Department of Public Social Services (DPSS) for Fiscal Year 03/04. The GAPP funding provides child care services for eligible families and/or children meeting criteria as set by CDE in accordance with the California Education Code.
